**BUS/FCS/INT 4555.** Honors Research. (3-0-3) On Demand. Study of research methods and processes including defining research problems, and collecting and analyzing data. Students will conduct a literature review and prepare a research proposal. Prerequisites: Admission to the Business, Family and Consumer Sciences, or Industrial Technology Departmental Honors Program and/or approval of the Business, Family and Consumer Sciences, or Technology Honors Coordinator. Course may not be repeated.

**HON 1190. Honors Forum. (1-0-1) F.** The course is designed to introduce first-year University Honors students to the academy and opportunities and expectations for success at Eastern Illinois University. Students will also meet Honors faculty and discover undergraduate research, scholarship, and creative activity opportunities. They will learn of curricular and co-curricular opportunities and ways in which they might integrate their learning and experiences in order to enrich their college experience. Prerequisite: Admission to the University Honors Program. Course may not be repeated. WI
