Effective Date: Fall 2009

Proposed change: To increase the minimum Major GPA required for graduation from 2.00 to 2.50

Rationale: As part of on-going assessment efforts in the Department, and in response to recommendations from the SABPAC (SOPHE/AAHE Baccalaureate Program Approval Committee), the Department believes that raising the minimum major GPA required for graduation will assist in maintaining the academic rigor of our program.

In evaluating the impact of changing the minimum major GPA, the major GPA's of all students in the Community Health Option were tabulated each semester for 2 years. While less than 2% of all students in the Community Health Option fell below a major GPA of 2.50 in any given semester, each of those students subsequently left the University or was academically dismissed. Clearly, those with a major GPA less than 2.50 were not functioning at an academic level conducive to successful completion of the program, or graduating from EIU.
