2. 12-08, CMN 2020, Communication Research Methods (Revised Course; Added Technology Delivered).

Dr. Borzi presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Dr. Reid left the meeting during the presentation and discussion of agenda item 12-08.

Ms. Eskew moved Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Summer 2012.

CMN 2020. Communication Research Methods. (3-0-3) On Demand. This course introduces students to the communication discipline through encountering its publications and resources. We will focus on the major areas of study and inquiry in communication studies, different research methods, and the use of APA style. Students will work on a variety of research and writing activities throughout the semester. WI

3. 12-09, CMN 2650, Introduction to Organizational Communication (Revised Course).

Dr. Borzi presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Ms. Ruholl moved Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Summer 2012.

CMN 2650. Introduction to Organizational Communication. (3-0-3) Organizational Communication. This course includes basic theories, structures and functions of communication in business and professional settings. It also includes effective leadership, decision making, and management of communication techniques.

4. 12-10, EIU 4172G, Communication, Organizations and their Environments (New Course).

Dr. Borzi presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Dr. Hoerschelmann and Ms. Clouston left the meeting during the presentation and discussion of agenda item 12-10.

Dr. Klarup moved Dr. White seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Spring 2013, pending course fee approval.

Note: EIU 4172G will be placed under the Senior Seminar segment of General Education.

EIU 4172G. Communication, Organizations and their Environments. (3-2-3) S, SU. Communication, Orgs/Environs. This course explores contemporary communication issues in organizations and how they (re)create themselves and their environment(s). Through an in-depth case study and a significant off-campus field experience students will conduct original research. Majors in Communication Studies are excluded. Prerequisite: Completion of 75 semester hours. WI

5. 12-11, EIU 4173G, Environmental Communication (New Course).

Dr. Borzi presented the proposal and answered questions of the council.

Dr. White moved Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, effective Summer 2012.

Note: EIU 4173G will be placed under the Senior Seminar segment of General Education.

EIU 4173G. Environmental Communication. (3-0-3) On Demand. This course investigates environmental communication, focusing on persuasive efforts by institutions, corporations, movement leaders, scientific experts, politicians and citizens to describe, persuade, and shape human interactions with the environment. Majors in Communication Studies are excluded. Prerequisite: Completion of 75 semester hours. WI

CHM 44001 - Undergraduate Research I. (Arr.-Arr.-1-6) (Arr.-Arr.-1-3) Laboratory or theoretical research in which the student works under the supervision of a faculty member. A written report is required. May be repeated once for credit and must be repeated prior to taking CHM 44002. Prerequisites and Notes: CHM 3500 or concurrent enrollment therein. Cumulative GPA of at least 2.50 (2.00 for chemistry majors with senior standing); permission of the instructor and department chairperson. A maximum of 3 semester hours from Undergraduate Research courses may be used toward chemistry major or minor requirements. Credits: 1-to-6 1 to 3

2. Change the allowable hours for CHM 44002.

CHM 44002 - Undergraduate Research II. (Arr.-Arr.-1-6) (Arr.-Arr.-1-3) Laboratory or theoretical research in which the student works under the supervision of a faculty member. A written report is required. May be repeated once for credit and must be repeated prior to taking CHM 44003. Prerequisites and Notes: CHM 3500 and two semesters of CHM 44001. Cumulative GPA of at least 2.50 (2.00 for chemistry majors with senior standing); permission of the instructor and department chairperson. A maximum of 3 semester hours from Undergraduate Research courses may be used toward chemistry major or minor requirements. Credits: 1 to 3

3. Amend the allowable hours for CHM 44003.

CHM 44003 - Undergraduate Research III. (Arr.-Arr.-1-6) (Arr.-Arr.-1-3) Laboratory or theoretical research in which the student works under the supervision of a faculty member. A written report is required. May be repeated once for credit and must be repeated prior to taking CHM 44004. Prerequisites an Notes: Two semesters of CHM 44002. Cumulative GPA of at least 2.50 (2.00 for chemistry majors with senior standing); permission of the instructor and department chairperson. A maximum of 3 semester hours from Undergraduate Research courses may be used toward chemistry major or minor requirements. Credits: 1-to-6 1 to 3

4. Update the allowable hours for CHM 44004.

CHM 44004 - Undergraduate Research IV. (Arr.-Arr.-1-6) (Arr.-Arr.-1-3) Laboratory or theoretical research in which the student works under the supervision of a faculty member. A written report is required. May be repeated once for credit. Prerequisites and Notes: Two semesters of CHM 44003. Cumulative GPA of at least 2.50 (2.00 for chemistry majors with senior standing); permission of the instructor and department chairperson. A maximum of 3 semester hours from Undergraduate Research courses may be used toward chemistry major or minor requirements. Credits: 1 to 6

Attachment A

Interdisciplinary Minor in Environmental Sustainability

This minor provides students with the skill set needed to be competitive in a job market focused on the applications of environmental sustainability. Students will take courses in alternative energies and sustainability as well as biogeochemical aspects of environmental sustainability. The minor also provides examples of the applications of environmental sustainability to various social systems. Existing prerequisites for courses must be satisfied.
