b. Academic Affairs – Dr. Addison reported that the Academic Affairs Subcommittee met on November 19, 2003. Discussion focused on suggested changes to the VPAA's Goal Statement, including a modification of the language regarding targeting of new students, and the addition of a statement concerning policies and procedures to support the recruitment and sponsorship of foreign-born faculty.

Housing and Dining Services has a Revenue Bond Committee who helps with housing rates.

The President reviewed the current status of the University budget, the projected state budget, and funding for higher education. He discussed the relationship between enrollment and the budget. By February, each of the direct reports will submit revised focus statements with proposed FY05 and FY06 work-plans in the context of flat and/or reduced budgets.
