# i. President Administrative Report

The President reported that spring session in Springfield will begin in February with the Governor's budget address. Our budget request is 6.9 %. The new increase in minimum wages went into effect on January 1, 2020. The minimum wage went from \$8.25 to \$9.25, and on July 1 the rate will go from \$9.25 to \$10.00. Beginning January 1 recreational cannabis can be purchased, but use on college campuses is prohibited because of federal law.

# ii. Vice President for University Advancement

It was reported that the total number of donors has decreased, but the donor dollars increased. The donor retention rate is near 35%. An alumni event is scheduled for Scottsdale, AZ on February 7-9. University Advancement will be hiring a Development Director in the near future.

## iii. Vice President for Academic Affairs

Vice President Gatrell reported that his subcommittee did not meet. The dean searches are progressing with interviews for the COE dean and CLAS dean starting next week. The feasibility study for the nursing program was approved by the Illinois Board of Nursing.
