Dear Mr. Miller:

Pursuant to state open records laws, I am requesting several documents as part of a joint project between USA TODAY and Indiana University's National Sports Journalism Center:

**1. The equity/revenue-and-expenses report completed by the athletic department for the National Collegiate Athletic Association for the 2014 fiscal year.** This report is a multi-page document that had to be submitted to the NCAA by Jan. 15, 2015. It contains 38 revenue and expense categories, followed by specific breakdowns of each of those categories, by sport and gender. I am requesting the full report, including the detail tables and the Statement of Revenues and Expenses that appear at the end of the report. PLEASE NOTE: The NCAA report is different than the equity report that is sent to the U.S. Department of Education for Title IX compliance.

**2. The current contracts for the men's and women's basketball head coaches.** If a contract is under negotiation, please forward the current contract but let me know that a new contract may be forthcoming. If there is no contact for one or both, please forward the letter(s) of intent or other document(s) outlining each coach's conditions of employment -- including bonus structure -- and/or a current statement of salary.

**3. The current contracts for the three full-time men's basketball assistant coaches.** If a contract is under negotiation, please forward the current contract but let me know that a new contract may be forthcoming. If there are no contracts, please forward the letters of appointment or another document that lists the coaches' conditions of employment -- including bonus structure -- and/or their current salaries.

**4. The most recent athletically related outside income reports for the five coaches listed above: the men's and women's basketball head coaches and the three men's basketball assistants.** This is the annual document filled out each year by all coaches to comply with NCAA bylaw 11.2.2, under which athletic personnel must report income earned from sources other than the university. Since there is no due date specified by the NCAA, please forward the most recently signed report.

If possible, please provide the requested documents electronically. With regard to the equity/revenue-and-expenses report in Item 1 of this request, I request the data be provided in HTML or Excel format. We have had problems with some of the report's tables being cut off when it is provided as a PDF, but this problem does not occur in HTML or Excel. If you must provide the report as a PDF, please make sure none of the tables -- for example: Detail Table 17, Athletic Student Aid -- is cut off. If you provide the data in Excel format, please ensure that the Statement of Revenue and Expenses is included.

Please send them as attachments to my email address, [jiweinre@umail.iu.edu](mailto:jiweinre@umail.iu.edu). If it is necessary to mail the documents, please use the address below.

Please respond within the number of days prescribed by law or provide either an explanation of when the record will be provided or a statement of the statutory exception authorizing the withholding of all or parts of the record and the name and title of the person responsible for the denial.

If the fee will be more than \$20, please let me know in advance.
