V. 01-02, Early Childhood Teacher Certification Program, Revision.

Dr. Greathouse and Dr. Shank presented the proposal and answered questions of the Council. The motion passed unanimously.

This action approves the following to become effective Fall 2001:

Effective Fall 2001, Early Childhood (EC) majors and EC majors with dual certification will be assigned during the student teaching semester to a split placement, eight (8) weeks in preschool and eight (8) weeks in primary grades.

VI. Executive Director's Report.

Upcoming:

On February 23, 2001, Larry Smith, Chair of Elementary Education Programs at Ball State University, will be visiting our campus. He will explain what NCATE will be looking for in the University's Plan. He will review some assessment outcomes and how to build programs that will meet the new NCATE Standards.

NCATE, the Council that governs Teacher Education, will be on campus this fall to see how things are done at Eastern Illinois University. The Standards that Eastern Illinois

University has to follow will be the new NCATE Standards. Representatives will look at

our student's outcomes and assessment. We will have to show them our plan on what we want to accomplish with our program.

Title II of the Federal Higher Education Advertisements focus on improving student achievement. In conjunction with this requirement, teacher education test results will be released to the federal government in April. It is important that we cultivate positive public relations in regard to this release.

PT3 Grant (Preparing Tomorrows Teachers to use Technology.) There is grant money to support technology in K - 12 education. Faculty members need to look into this grant to see if they qualify to receive some of funding.

VII. Communication.

Interim Provost Wall and Dr. Weber provided an update on the FY 02 budget, comparing tentative state appropriations to EIU's actual obligations. University-wide planning and budgeting efforts are being directed at this issue, with a focus on identifying and addressing EIU's highest priorities while maintaining the quality and integrity of our programs and services.
