### Liaison Reports:

- C. **VPBA Report** We received \$4 million from the state last week. We received word today that the MAP will be paid. We still have \$7 million outstanding for FY17. For FY18 we have received \$16 million and still have \$21 million outstanding.

There are still concerns about cash flow in May/June. If we get the remaining funds from the state we should be fine. There is a rumor that the FY19 budget will not be passed until after the election. We are working to ensure we can financially make it through Summer 2019.

Enrollment for Fall 2018 looks good. Applications are up 80%. We need to get them to commit. Deposits are up 40% over last year. 10<sup>th</sup> day numbers are what are our true numbers.

Cash flow is better though not perfect. All budgets, all ledgers have been loaded. We needed to cut \$3.5 - \$4 million to meet current level. No cuts to personnel.

The Vice President University Advancement will not be filled at this time. We are currently looking for a Bond Accountant; Civil Rights Director; and Director for New Student Programs. Our next searches will be Dean for Booth Library and Dean for Lumpkin College of Business and Applied Sciences (LCBAS). Dr. Minnis has been named interim Dean for LCBAS.

Budget Director search has been separated from the Institutional Research position. Originally a search was conducted for the Director of Budget and Institutional Research. There are beliefs that the salary is too low for candidates to apply. Salaries are too low across campus.

D. EAC Report – There are still discussions being conducted about positions being classified as civil service (CS) or Academic and Professional (A&P). Jobs formerly moved to A&P might need to be moved back to CS.

EAC wants less admin categories such as President, Vice Presidents, Deans and Faculty. Currently coaches, philanthropy directors, admission directors, doctors/nurses, and other director positions are A&P. There needs to be rules on how to handle these moves. It can impact benefits. Everything takes time as the EAC only meets quarterly and they are working with the HR committee on these changes. So back and forth takes time. Merit board makes ultimate decision. Should have a final decision by March.
