Facilities projects: Elevator projects are closer to starting. Science building HVAC, CDB approved engineer, PPB has to approve, it is doubtful work will start this summer. Lantz stairs: concrete is complete, laundry facility nearing completion. \$100,000 DECO Grant for Booth North Steps – there is a concern about steel under concrete which could seriously impact budget. Union porcelain is here waiting weather to install. Union will be power washed. CDB HVAC work at Old Main and Blair is progressing and awaiting \$145,000 of EIU funds. Roberson auditorium donor funded work continues. EIU also received a donation to renovate a tutoring room in Physical Science. CDB is starting Electrical upgrades project at Old Main and Buzzard. The A and P to Civil Service is continuing, the audit has been moved back to June.
