- C. VPBA Report Paul McCann EIU met with Springfield the last 2 weeks RE FY21 Budget request. EIU asked for 6.6%, IBHE requested 5.9%, The Governor proposed 5% contingent on the graduated income tax passing in the November 2020 election. EIU internally will budget no increase. Dale Righter is interested in taking some programs out of the Governor's proposal and funding education now. EIU is talking to Springfield, CDB and GOMB about releasing the emergency funding, 18.9 + 5.4 Million authorized. Governor released 11.8 million for planning the New Science Building, which will probably be located South of Tarble Arts on the "tundra". CDB is bidding the design time estimate for design is 12-18 month, estimate for construction is years. State has stated the construction funding will follow. There will be an open enrollment benefits choice in May 2020. CMS will be on campus to provide information and answer questions. We assume a cost increase, no details, AFSCME has no details yet. There will be 3 types of plans.
