April 12, 2012

The April 12, 2012 meeting of the Council on Academic Affairs was held at 2:00 p.m. in Room 4440, Booth Library.

I. Approval of the April 5, 2012 CAA Meeting Minutes.

Dr. Reid moved and Dr. Klarup seconded the motion to approve the minutes. The minutes of April 5, 2012 were approved as written.

1. April 4, 2012 memorandum from Dean Izadi, LCBAS, requesting executive action to change the grading mode for FCS 1121 and revise the course titles for FCS 2100 and 2190.

III. Committee Reports:

- Dr. Klarup announced the 2012 Faculty Laureate award recipient on behalf of Dr. Hoerschelmann, Chair
 of the Faculty Laureate Selection Committee, who couldn't attend today's meeting. Dr. Klarup, a
 member of the Faculty Laureate Selection Committee, said that Dr. Jeffrey Stowell was chosen as the
 2012 Faculty Laureate.
- 2. Dr. Mitchell reported that representatives from CAA, CGS, COTE, and Faculty Senate met for the first time. The meeting was a part of shared governance which resulted from discussion by Faculty Senate to increase communication across the councils. It was also to provide updates and inform each other of what was happening in each group.

- 3. Dr. Mitchell provided an update of the proposal to revise the course proposal format form. He explained the CAA Executive Committee was waiting for the subcommittees of CAA's Learning Goals Committee to submit white papers so references to those papers could be inserted into the course proposal form. The council discussed it and it was indicated the white papers probably wouldn't be ready to post to the CAA's website this semester. As a result, the proposal could be submitted to the council without references to the papers.
- 4. Dr. Mitchell explained that Ms. Billie Rawlings, Academic Affairs, submitted a communication indicating that when reviewing the nominations for the Achievement & Contribution Awards (ACA) Committee, she noticed that CAA had nominated Dr. Lucas and Dr. Caldwell (See the 3/8/12 CAA Meeting Minutes). Dr. Lucas is not eligible to serve on the committee because he is a department chair. As a result, Ms. Rawlings had requested the council submit the name of another tenured/tenure-track faculty member for the ACA nomination process.
 - Dr. Mitchell asked for a volunteer. The council discussed it. There were no volunteers at the meeting today. The item will be revisited at next week's CAA meeting. Also, it will be clarified whether a member of CAA must volunteer or if the council could submit the name of a person outside of the council.
