This course focuses on the unique application of the marketing mix to sporting events, including the conceptualization of sport fan identity and attachment, sport sponsorship relationships, and participative sport involvement. This course is restricted to Kinesiology & Sports Studies majors. Prerequisites: A grade of "C" or better in KSS 2761 and BUS 3470.

- 3. 13-52, Kinesiology & Sports Studies: Sports Management Concentration (Revised Concentration).

Grade and credit hours for this course will be removed if student already has credit for or is registered in EDF 2555G. Prerequisite: Admission to the Honors College. WI
