Dr. Tidwell and Dr. Kim presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Dr. Gronnvoll moved and Ms. English seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Spring 2014. Note: This course will replace JOU 3903 and JOU 3951. Since it will impact academic programs, the council requested program changes be submitted identifying where the JOU 3903 and 3951 courses will be taken out and replaced by JOU 3970 in the catalog.

JOU 3970. Race, Gender, and the Media. (3-0-3) On Demand. This course investigates the role of the media in constructing, reinforcing, and/or challenging the notions of race, gender, and sexuality in the U.S. Students analyze issues relating to representations in diversity in the media, media workforce, media history, media ownership, among other issues. Students will develop critical perspectives in creating and understanding media messages. Prerequisite: "C" or better in ENG 1002G. The prerequisite course cannot be taken concurrently with this course. WI
