The January 15, 2004 meeting of the Council on Academic Affairs was held at 2:04 p.m. in Booth Library Conference Room 4440.

I. Minutes

The minutes of December 11, 2003 were approved as amended. The effective date for the Speech Communication executive action items listed under the CAH pending executive action section on page three of the minutes should read Fall 2004, not Spring 2004.

II. Communications:

Dr. Methven followed up on a question that was raised at the last meeting regarding waiver # 03-140 listed on the LCBAS November Waiver Report. He announced that he contacted Lumpkin College of Business & Applied Sciences regarding the question. He was told the student's waiver request was denied because the requested course on the waiver request was not included on the General Education course list of courses that native EIU students can waive.

In order to best represent council members' views at the Faculty Senate meeting, Dr. Methven requested input from the members. He distributed copies of agenda materials regarding the proposal that were originally viewed at the October 2 meeting to remind individuals of what was discussed at that meeting.

A more in-depth discussion regarding this issue occurred at the end of the meeting.

The proposal deals with handling courses originally taught on campus in classrooms and now being taught online. Dr. Tidwell plans to submit the proposal to CAA once it is approved by CGS.

2. Format for CAA discussion of the IBHE Program Review.

He distributed a handout in which he highlighted key points taken from the article "Seven Principles for Good Practice in Undergraduate Education" located at the AAHEBulletin.com web site. This handout could be used to assist council members in their discussion regarding the creation of an appropriate program review format.

After a brief discussion, the council decided that the decision regarding the program review format should be reviewed as an agenda item.

Dr. Dilworth moved and Dr. Tidwell seconded the motion to add this item to next week's meeting agenda. The item will be identified as agenda item #04-17.

V. Items Acted Upon.

Dr. Scott and Dr. Vietto presented the proposal and answered questions of the council. After discussion, the proposal was amended. A semi-colon was added to the course prerequisites and a statement was placed at the end of the paragraph located at 2.d.3.

The motion passed unanimously.

SPEECH COMMUNICATION (B.A.)

Major

The Department of Speech Communication is a community of students and faculty interested in exploring the complex and dynamic nature of communication in multiple contexts. Students develop critical thinking skills, a sense of social and ethical responsibility, the ability to develop effective message strategies, and the ability to successfully live within complex social environments.

Graduation from the program requires a grade of C or better in each of the department's four core classes (SPC 2010, 2020, 2030, 2040) and submission of a student portfolio. The major GPA is calculated on all courses listed as appropriate for meeting major requirements. SPC1310G, SPC1390G or any transferable equivalent cannot be used as an elective in the Major.

2. Revise the Speech Communication Minor electives.

Minor in Speech Communication

This minor provides students with a way to enhance their educational experience by participating in a program of study that provides a well-rounded approach to understanding the role of communication in society and how to engage in effective communicate strategies in multiple social contexts.

Application Criteria

To apply for admission to upper-division standing in the School of Business, a student must:

- 1. Be admitted to EIU;
- Submit an application to the School of Business prior to the first day of classes for the semester of desired admission;
- Have earned a cumulative GPA of at least 2.50 (2.75 for students applying to the accounting program) and have all transcripts on file at the time of application:
- 4. Have completed at least 60 semester hours by the end of the semester in which the student makes application;
- 5. Have completed (with a grade of C or better in each), or be enrolled in, the following four tool courses or acceptable equivalent at a transfer institution:
 - MAT 2120G Finite Mathematics
 - BUS 1950 Computer Concepts and Applications for Business
 - BUS 2102 Managerial Accounting
 - BUS 2810 Business Statistics I
- 6. Be in good academic standing; and
- 7. Be classified as pre-business.

Students intending to major in accounting are subject to additional admission requirements as detailed on p. 72.

A student cannot be enrolled in any 3000 level business courses at the time of application to the School of Business.

2. Modify the School of Business policy on grading.

Old policy: Students may receive a grade in an upper division business course a maximum of two times. After a grade has been received in an upper division class at EIU, the School of Business will not accept subsequent transfer of an equivalent course from another school.

New policy: Students may receive a grade in an upper-division business course a maximum of two times. After a grade has been received in an upper division class at EIU, the School of Business will not accept subsequent transfer of an equivalent course from another school unless the School of Business has given prior written approval to enroll in the specific course at the specific university, which must be AACSB-I accredited

- Students pursuing a degree other than the B.S. in Business cannot count more than 30 semester hours of business subjects toward fulfillment of their bachelor's degree requirements
- Business majors must complete at least 50% of the semester hours required for graduation in non-business courses.
- 3. To qualify for the B.S. in Business degree from EIU, students must take at least 50% of their business credit hours at EIU.
- 4. Students may receive a grade in an upper-division business course a maximum of two times. After a grade has been received in an upper division class at EIU, the School of Business will not accept subsequent transfer of an equivalent course from another school unless the School of Business has given prior written approval to enroll in the specific course at the specific university, which must be AACSB-I accredited
- Upper-division business students who are academically dismissed from EIU
