- 1. Pursuant to applicable authority, I am writing to request copies of the following "Documents" for the athletic department staff listed below:
 - a. Current employment Contract for the 2010-2011 academic year (Letter of intent, form agreement, or applicable document / record which shows annual compensation and start/end date of employment). If an employee does not have a formal written agreement, please provide (ideally in a spreadsheet or table format): Name, Compensation, and Start/End Date (or write "At Will" if applicable).

- 2. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e., signed, fully executed) and entered into at any time from March 1, 2010 to the date of this request between the University's Department of Athletics and other Universities' Departments of Athletics for non-conference football games and non-conference men's basketball games between the schools' respective football and men's basketball teams for the years 2010 through 2025. In addition for women's basketball and baseball, I am requesting a copy of any contract or written agreement in force (i.e., signed, fully executed) between the University's Department of Athletics and other Universities' Departments of Athletics for non-conference games between the schools' for the years 2010 through 2025.
- 3. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e., signed, fully executed) between the University's Department of Athletics (or its affiliates) and third parties regarding all of the following categories of subject matter:
 - a. Multi-media rights (through firms such as IMG, ISP, Learfield, Nelligan, etc).
 - b. Pouring rights, sponsorship, ad and promotional rights (through firms such as Coke, Pepsi, etc).
 - c. Apparel rights for athlete competition (through firms such as Nike, Adidas, Reebok, Under Armor, etc).
 - d. Trademark licensing (through firms such as Collegiate Licensing Co.).

- e. Ticketing management (through firms such as Paciolan / Ticketmaster, etc).
- 5. Pursuant to applicable authority, I am writing to request a copy of the most recent NCAA Annual Financial Report provided to the NCAA (i.e., for 2008-2009).

If the requested records described above are available in electronic format (e.g., PDFs or CD), then I would prefer to receive the information in that format instead of paper copies. If you are able to email the records, I request all PDFs in a single WinZip file in the responsive email (no password protected files, please). If you are unable to email the records or you require an address to process this request, please find below my mailing address.

Just a reminder, all of the requested information above will be used exclusively to support the mission of your athletic department and will not be disclosed to the public.
