Everly Withdraws
Ray E. Everly has withdrawn as a
member of the Jasper County Selective Service Board to succeed Eugene
R. Warren, who resigned when he

went to Chicago. Mr. Everly said his duties as a director of the First National Bank, adjutant of Jasper post, American Legion, and a sub-recruiting officer for the Navy would prevent him from accepting.

The Board has been reclassifying

men previously placed in classes 4-F and 1-B, and expects to obtain quite a number of men from these groups to fill quotas, before it becomes necessary to draft any more married men. Under regulations now in force, the quotas will be equalized to call all unmarried men in the United States before any of the Boards begin to call

men with dependents.

The local Board has never missed a call for men and Boards in neighboring counties have missed all or parts of several. This has resulted in their appearing to be sending more

in their appearing to be sending more (or less) men than Jasper county in proportion to population. With the group which went this morning, all single men in 1-A were exhausted, unless others are transferred from 4-F classifications.
